

My name is Joseph Barnabas. I am seeing people hurt and dying in my country and around the world with societies' institutions acting, for the most part, in willful ignorance, denial and callous disregard, censoring the truth and promoting lies, propaganda and an ideological narrative that is gradually enslaving the people in totalitarian socialism – the dawning of a new international socialist (INAZI) Dark Age. This book is my righteous indignation against what is happening to my family, friends and fellow countrymen...considered 'ignorant country-folk' in woke elites' terms.

The purpose for writing, "COVID-19 – AN **URGENT HEALTH MESSAGE** Or A DEADLY FRAUD," is to alert and to alarm citizens of Canada, the United States and the 'Free World' of the emerging socialist one-world government, and the coming 'age of tyranny.' This evil monstrosity is taking form through a flood of worldwide government and health authority **propaganda** and **misinformation** concerning the COVID-19 pandemic, aided and abetted by their proxies, the mainstream news and social media. These global elite, government-controlled agencies have pronounced a false narrative about almost every aspect of the COVID pandemic and the "vaccines" that are supposed to protect people from it. They pose a real danger to every citizen in the world's free democracies, as incessant propaganda and lies lead the masses into individual danger and collective suicide from what can, at best, be called, "*propagandized bioterrorism by injection,*" as described by Dr. Peter McCullough, professor of medicine and vice chief of internal medicine at Baylor University, an epidemiologist, cardiologist and

internist who also teaches at Texas A & M. He said suppression of early COVID treatments, **especially Ivermectin**, was tightly linked to the development of a vaccine. But the vaccines are a fraud as illustrated by molecular biologist, Dr. Judy Mikovits, in her interview with Dr. Joseph Mercola,

“COVID-19 vaccines are not vaccines. They are a fraud. Unlike real vaccines, which use an antigen of the disease you’re trying to prevent, the COVID-19 injections contain synthetic RNA fragments encapsulated in a nanolipid carrier compound, the sole purpose of which is to (temporarily) lessen clinical symptoms associated with the S-1 spike protein. They are experimental gene therapies that are falsely marketed as vaccines, likely to circumvent liability. World governments and global and national health organizations are all complicit in this illegal deception and must be held accountable.” (Dr. Joseph Mercola, *The Difference Between mRNA Injections and Vaccines*, The Epoch Times, March 7, 2022)

As the COVID-19 crisis deepens basic freedoms are being stripped away by misguided and politically-motivated agendas. Mutated variants are continuing to emerge; first delta in August to October, 2021, and now omicron in late 2021 and early 2022. More lives are lost as forced vaccination, “or else,” becomes the norm. In a January 7, 2022, Press Conference Canada’s Federal Health Minister Jean-Yves Duclos stated, “provinces will, and should, require mandatory vaccination of their citizens.” Duclos said he believes mandatory vaccinations will happen in Canada. Yet, a recent Alberta poll with 7428 votes showed 83% versus 17% of the 7428 votes were against mandatory vaccination. Authorities are trying to vaccinate our way out of COVID-19, not realizing the impossibility of this illusionary strategy. In Alberta, a chart shows the active case count leveling out at 80-82% which is higher than the total population double-dose rate of 73%. The ‘vaxxed’ now outnumber the unvaccinated in YYC hospitals. Yet, the unvaccinated are still being blamed for these results.

The unvaccinated are being designated social pariahs, and not just in Canada, but in other parts of the world also. In a January 4, 2022, missionary letter, a Filipino pastor friend wrote, “In National Capitol

Region mass testing was pushed and restrictions on movement was ordered. The unvaccinated are advised to stay home. Violators face fines of up to P 50,000 or imprisonment of two to six months.” Waking up out of the “collective trance” that seems to be afflicting society as a whole, one can see the work of intentional evil and destruction coming at Canadians, Americans and our friends in other countries.

This book intends to show that the basis for the misinformation and propaganda surrounding COVID-19 is deliberate, coming from well-placed operatives in our health care systems, and acquiescent and weak leadership in government, foreign players, most notably the Chinese Communist Party, from which this virus was designed and let out to create death and havoc worldwide. Looking at the ‘big picture, it is difficult not to come-to-the-conclusion that the COVID-19 pandemic was planned and executed deliberately by a cadre of world elites working in concert with Communist China, and nefarious actors within our own borders, many of whom are Canadian and American citizens. Most people are unaware of what is happening because of the sophistication and dominance of the technology being used to brainwash them. Alberta, Canada, is home to Alberta Health Services (AHS), the largest provincial health service in the country. Therefore, most of the references and statements concerning **misinformation** accountability refer to this province and are mentioned in the course of the writing. Suffice it to say, the governments and top health care bureaucrats are largely responsible for this unfolding disaster because of their lies to the people whose trust they are supposed to uphold.

In June, 2020, AHS signed on to the World Economic Forum’s global health initiative, placing itself squarely in the globalists camp and the WHO’s territory. Therefore, what is going on in Alberta is happening as a small part of a worldwide agenda.

An encyclopedia could be written about the COVID-19 news just in Canada, not to mention other jurisdictions. The writer will try to keep his references down and mostly referring to Alberta, Canada.

However, the news surrounding COVID-19 here applies to just about everywhere around the world. Some countries are fighting the narrative but are being pressured to give in to it.

Steve Kirsch, executive director of the COVID-19 Early Treatment Fund, explained his motives and sacrifices in trying to get the truth out concerning the COVID mandates and vaccines.

“We’ve lost all our friends. I was forced out of my job because I wanted to speak out against the vaccines. I’m losing money on this because I’m funding a lot of the things out of my personal pocketbook. The donors that donated to the early treatment fund, none of them, not a single one, is supporting the effort to get the truth out about how dangerous these vaccines are and how wrong the mandates are. My motivation is 100% on saving lives. That’s my reward in life. If I can save one life, my life was worth living. If I can save 100 lives, even better. If I can save 100,000 lives that is more meaningful than anything I’ve ever done or will do.” (Steve Kirsch, **COVID shots are the Deadliest ‘Vaccines’ in Medical History**, Mercola website, November 21, 2021)

Informed Consent

First of all, why do we need informed consent for medical procedures, including vaccination?

The purpose of **informed consent** is to give people all of the data related to a medical procedure so they can make an educated decision before consenting. In the case of COVID-19 injections, such data initially weren’t available, given their emergency authorization, and as concerning side effects became apparent, **attempts to share them publicly were suppressed.** (**The Leaky Vaccine Breakthrough Variant is Here**, Mercola website, October 26, 2021)

“These vaccines, and the policies surrounding them, are violating many of our most precious held ethos, specifically **Informed Consent**, which previously **was** so sacred to us all. And it was precisely this issue of Informed Consent that was terrifyingly disregarded in Germany from the 1920’s through the Nazi (National Socialist) regime. It was for this reason that the globally recognized **Nuremberg Code** was written. The very first words of that Code are: **THE VOLUNTARY CONSENT OF THE HUMAN SUBJECT IS**

ABSOLUTELY ESSENTIAL. That Code is currently being **completely disregarded**, and the significance of this cannot be overstated.” (Anonymous M.D., Dear Parents Letter, November 10, 2021, 28 pp.)

Alberta Health Services (AHS) and its affiliates, the College of Physicians and Surgeons of Alberta (CPSA) and the CPSA Council are guilty of suppressing vital information on COVID-19 from the public which would permit individual Albertans from giving their informed consent to the COVID-19 vaccinations. Draconian forced workplace vaccination mandates and vaccine passports guarantee no one will be given the freedom to make informed consent to the **jab**. Thousands of law-abiding citizens of this province are currently out of a job or on unpaid leave of absence in direct violation of their right to informed consent concerning these gene therapy **jabs**.

The CPSA Council completely and hypocritically disregards its own ‘STANDARDS OF PRACTISE’ guideline which states:

“A care provider must obtain consent and ensure that the patient is fully informed and understands any medical examination procedure or treatment before it takes place.”

AHS (Alberta Health Services), CPSA (College of Physicians and Surgeons of Alberta), CPSA Council, CMOH (Chief Medical Officer of Health), Dr. Deena Hinshaw, and her Medical Advisor Deputy Medical Officer of Health, **¹Dr. Jing Hu**, are guilty of propagating misinformation, hindering informed consent concerning COVID-19 and promulgating divisive, misleading and unethical vaccine mandates leading to a collective criminal assault against the citizens of the Province of Alberta under S. 265(1) and S. 265(3) of the *Criminal Code of Canada*. They have deceived Albertans by a well-orchestrated flow of propagandized misinformation, forcing upon them an unwanted and unneeded mRNA gene therapy injection program. They have intentionally applied, directly and indirectly, force and coercion on its citizens to get the Pfizer and Moderna mRNA injections without their informed, willing CONSENT through pre-planned, illegal AHS and governmental edicts and mandates that require unwilling compliance through the exercise of authority and threat of the loss of livelihood upon many thousands of hard-working

Albertans who do not want to take these new and inadequately tested “vaccines.”

Dr. Sucharit Bhakdi, was a member of the Max Planck Institute of Immunobiology, and chair of the Department of Medical Microbiology and Hygiene at the University of Mainz, Germany, and has worked on vaccine development. He says he’s “certainly pro-vax with regards to the vaccinations that work and that are meaningful.” However, concerning the COVID-19 “vaccines,” he had this to say,

“Gene-based vaccines are an absolute danger to mankind and their use at present violates the *Nuremberg codex, such that everyone who is propagating their use should be put before tribunal,” Bhakdi says. “Especially the vaccination of children is something that is so criminal that I have no words to express my horror ... We are horribly worried that there’s going to be an impact on fertility. And this will be seen in years or decades from now. And this is potentially one of the greatest crimes, simply one of the greatest crimes imaginable ...children are not in the position to understand it. Therefore, they cannot give informed consent. Therefore, they cannot be vaccinated. If grownups have been informed and want to get the shot, that’s all right. But don’t force anyone to get the shot. It has to be by informed consent only.”

*It is not a binding international law, BUT according to the college dictionary, it is “a body of principles governing; the standard of morality prevailing in a society, class, profession; as the social code; the code of honor,” etc. By abandoning the Nuremberg code Western society is showing that it holds social morality and honor in contempt, and does the exact opposite of what is right, true and just. National socialist Germany did exactly the same thing during Hitler’s rule of terror from 1933 to 1945.

Of course, **informed consent** is also virtually impossible even for adults, as they’re only given one side of the story. All side effects and risks are censored virtually everywhere and discussions about them are banned. The U.S. government is even pushing to criminalize discussion about COVID injection risks.

Almost all social media platforms are spreading **misinformation** about COVID by censoring information they don't like. For example, "YouTube will block all anti-vaccine content moving beyond its ban on false information (**misinformation**) about the COVID-19 vaccines. The moves come as other tech giants like Facebook and Twitter have been criticized for not doing enough to stop the spread of false health information on their sites." (**Plug pulled on anti-vax content**, The Calgary Sun, September 4, 2021)

How can **informed consent** be given when everything opposing the mRNA "vaccines" is censored. In the absence of free speech and the discussion or debate between opposing points of view **informed consent** is the casualty, and people become the victims.

MISINFORMATION

The real enemy at this point is the propaganda that keeps fear alive. This is exactly what AHS has done from the outset of the pandemic in early 2020 and continues to do at the time of this writing in November, 2021.

Definition: “false or untrue statements; to tell news or facts wrongly in order to coerce or deceive.”

The mainstream news media and governmental health agencies have participated in an unprecedented campaign of **misinformation** against the citizens of Alberta and Canada at large. Similar patterns of universal brainwashing propaganda characterize Communist China and every dictatorship in recent memory. They subjected their citizens to state collectivism and made them aggressive in state collectivism that ultimately destroyed them.

The COVID-19 ‘pandemic’ is following this pattern of deception. The federal and provincial health services and governments continued to promote and **mandate unproven mRNA “gene therapy” vaccinations** on nearly ‘everyone,’ including 5 to 11-year olds. In **“Unravelling the Forces Behind the Plandemic: A Special Interview with Mikki Willis,”** Dr. Joseph Mercola stated,

“Recommending vaccinations that are likely to kill, injure or harm them (children) when it’s not even remotely necessary, is certainly behind this agenda.”

Mikki Willis replied,

“My child is not even in the category of being at risk at all. We have no idea what their long-term effects. These late-night TV hosts are saying that it’s immoral not to do it (i.e., vaccinate children). It absolutely blows my mind that any (pregnant) mother would take that chance.”

Dr. Mercola responded,

“Well, it doesn’t blow my mind because **they’re so effective at the propaganda. This is probably some of the most sophisticated propaganda in the history of mankind and the technology supports that.**”

Mainline news media in 2021 have unprecedented means of ideological censorship and the promotion of **misinformation**, disinformation and propaganda for political purposes. Their official countermeasures to ‘fight’ COVID-19 are essentially medical theatre, that is, vaccination, masking, social distancing, stay-at-home without help, etc. It is a vast propaganda machine on a scale that is almost unimaginable. Instead of a promised herd immunity, hundreds of millions of uninformed people around the world are being “**jabbed**” with dangerous mRNA “cocktails” in mass herd compliance to a litany of false information and forced mandates coming at them from every direction. And we are now in a pandemic of COVID-19 “waves” coming from the vaccinated because the jabs mitigate natural immunity and, therefore, the sought-after herd immunity.

Government and media are ostracizing and marginalizing those who publish scientific evidence countering their narrative. Persecution of these people is as stated by the creator of the mRNA vaccine technology,

“Those who are writing and speaking about science and health policy are now in danger of being targeted by the U.S. government (and Canada’s) as domestic terrorists for spreading ‘mis-, dis- and mal-information (MDM).” (Robert Malone, NIH Director Blames Dr. Mercola for Pandemic Continuation, February 21, 2022)

The ²AHS, CPSA and CPSA Council have accused their opponents of spreading **misinformation** when, in fact, they are the guilty party. Every one of the points listed below is considered accurate and true based upon the science and study of COVID-19 by highly qualified professionals from medical and science backgrounds. Each one contradicts specific **misinformation** put out by Alberta Health Services’ Deputy Medical Officer of Health, Dr. Jing Hu and the AHS spokesperson, Dr. Deena Hinshaw with the support of the CPSA and CPSA Council. This pattern of misinforming the public is happening in other developed countries, most notably the U.S.A. where there is a little more freedom to get to the truth publicly than in Canada. The Western democracies appear to be ‘targeted’ in a malicious and sinister agenda designed to destroy the fabric of society while rendering the population helpless under dictatorial governments.

An example of published misinformation is a recent HuffPost article which opposed the use of Ivermectin in treating COVID-19, stating,

“Health experts – the kind who practice on humans – agree that the best way to prevent yourself from catching the virus is to get vaccinated, wear a face mask and stay out of crowds.” (Mercola website, Sept. 13, 2021)

While AHS has written a document citing rampant **“misinformation,”** it is evident that AHS is the one engaged in **misinformation** within an orchestrated propaganda campaign. Vague allusions by AHS to a **“pandemic of misinformation”** does not constitute a response to well documented concerns such as the list following.

A retired medical doctor wrote,

“It is becoming apparent that there is something VERY sinister going on in this country.
